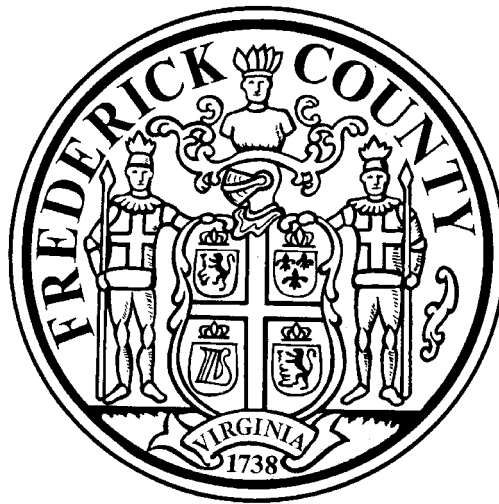

## **INSTRUCTIONS - SEWAGE DISPOSAL SYSTEMS INSTALLERS LICENSE**

### **FREDERICK COUNTY DEPARTMENT OF PLANNING AND DEVELOPMENT**

On February 24, 2010 the Frederick County Board of Supervisors approved revisions to Chapter 161 (Sewage Disposal Systems) of the Code of Frederick County. This ordinance revision contains a requirement that all persons engaged in the business of installing or repairing onsite sewage systems in Frederick County must apply for an Installation License from Frederick County. The Sewage Disposal Systems Installers License fee is \$300.00.

In order to apply for a Sewage Disposal Systems Installers License you must bring a copy of your Installation License issued Commonwealth of Virginia Department of Professional and Occupational Regulation (DPOR).

A Frederick County Sewage Disposal Systems Installers License is permanent and does not need to be renewed.

\* Please note that if you do not obtain an Installation License from Frederick County you will not be able to obtain any permits from the Virginia Department of Health. Property owners applying for an onsite sewage disposal system must provide the Virginia Department of Health with the name and license number of the person or company installing the system.
