BUSINESS RETENTION MANAGER PROJECT UPDATE

Sally Michaels, Business Retention Manager, gave an overview of projects under her supervision.

INCENTIVE POLICY

Mr. Barker explained this document governs all aspects of the local incentive process (i.e., who qualifies, process for approval, who conducts the audit of a company's performance, and who reviews performance agreements). Staff suggests the Board review this document annually. Building upon the approved 2017 Policy, staff has updated it to reflect current business targets and the average wage for the County. A copy of the proposed revised Policy was distributed to each Board member prior to this meeting.

Mr. Tibbs asked which business target had changed.

Mr. Lofton inquired if aerospace could be added to our targets. Mr. Barker stated the targets on the list are our first priority but that does not mean that others outside those parameters would not be considered. Business targets are revised annually based on where job growth is projected to occur and if the State does not forecast a large number of jobs for a specific business target, it is not included.

JOINT MEETING WITH FREDERICK COUNTY BOARD OF SUPERVISORS

Mr. Barker explained that the 2014 MOU between the EDA and Board of Supervisors calls for an annual discussion and review of the BOS's expectations for economic development.

1st QUARTER PERFORMANCE MEASURES

Mr. Barker reviewed the 2018 performance measures report which had been distributed to Board members.

Mr. Claytor remarked that property views for the 1st quarter increased significantly. Mr. Barker stated that client interest ebbs and tides and the report counts each view whether from the same client or a different one.

Mr. Crockett welcomed Mr. Wiley, a member of Winchester City Council.

Mr. Riley inquired if there were any plans to organize something locally later this year for our legislative group. Mr. Barker stated there has been some conversation about dovetailing on the BOS Transportation Forum. Mr. Lofton said he had no concerns about the EDA having a separate event.

Mr. Riley stated he prefers an event to focus on the County and such things as agribusiness and its growth and new industries here since the last time we sponsored a tour of the area for our legislators. He suggested including lunch at an agribusiness site.

Mr. Crockett said we need to develop an agenda to make it interesting for everyone. He also cited the need to maintain a relationship with legislators.

Mr. Lofton stated we need to arrange something early before proposed legislation for the next year has to be submitted.

Mr. Barker will submit ideas at the next meeting.

 - State economic development officials
 - State board of directors (i.e. VEDP, VDOT, CTB)
 - Federal elected officials
- Where the preferred timing?
 - Before November's election
 - o After January 1, 2020

Collective responses to these questions will heavily influence the event's agenda and timing. Staff will formulate event options after this discussion. The previously approved legislative agenda is enclosed.



FREDERICK COUNTY EDA LEGISLATIVE AGENDA 2019

Frederick County EDA believes it is vital that the Commonwealth of Virginia invest in programs with a positive return on investment that help create new jobs to make Virginia more competitive. Not only will this dramatically improve Virginia's position in the national business climate rankings, it will also positively impact both our quality of life and the state's fiscal health. To bolster Virginia's economic development competitiveness in the global marketplace, the Frederick County EDA recommends policy and budgetary actions that will support:

A SKILLED AND AVAILABLE WORKFORCE

Workforce Solution. To compete with top-ranked state workforce development programs (e.g., Georgia Quick Start and Louisiana FastStart), Virginia must create a world-class, turnkey, customized workforce recruitment and training incentive program available for significant expansions of existing firms as well as substantial new business facilities. Virginia must also seek opportunities to more directly engage higher education institutions in economic development projects.

High-demand Credential Training. Prospects and existing businesses need higher-skilled employees, and Virginians need affordable access to attaining credentials in demand by hiring companies. The Frederick County EDA endorses additional funding for pay-for-performance attainment of high-demand credentials delivered through the Virginia Community College System. These credentials demonstrate the availability of a skilled, motivated, and plentiful workforce in the Commonwealth

A RELIABLE AND SAFE TRANSPORTATION SYSTEM

The Frederick County Economic Development Authority fully recognizes that Frederick County must be a well-connected location. This is essential to existing and new businesses in accessing their suppliers and customers, as well as connecting to intermodal hubs leading to the global marketplace. A business will not go anywhere without easy access to well-maintained, high-capacity road networks that connect customers, distributors, and shippers. This is especially true for the manufacturing sector, a target business of the EDA. An excellent transportation network is essential for a well-functioning supply chain, as well as for the on-time delivery of goods to the marketplace. We strongly support policies to invest in infrastructure to enhance the state's competitiveness.

UNIVERSAL AFFORDABLE BROADBAND

Broadband access to all parts of the Commonwealth is essential to the state's competitiveness. It drives job creation, promotes innovation, and expands markets for Virginia businesses. Too many areas, including parts of Frederick County, still lack access to this crucial resource. We urge Virginia policy makers to move forward with plans to expand deployment of broadband to all corners of Virginia in partnership with public and private providers.

TOOLS FOR COMPETITIVENESS

Chief among Virginia's tools to be competitive are economic development incentives. Virginia must strengthen and grow its economic development toolbox. It is imperative that Virginia live up to the commitments it has made in the past by fully funding existing initiatives and commitments and by increasing funding to the economic development incentives that clearly deliver success for the Commonwealth. Frederick County EDA supports transparency and accountability with regard to the use and management of incentives, but such measures should not restrict the state's ability to be responsive and flexible to the needs of business.

Virginia Business Ready Sites Program (VBRS). Site readiness is important to Virginia's economic development efforts. Currently, Virginia has the lowest number of buildable/certified sites in the nation. Frederick County EDA supports increased funding for the VBRS program and other efforts to provide a more competitive product for those businesses looking to locate or expand in the Commonwealth.

Commonwealth Opportunity Fund (COF). COF remains Virginia's flagship economic development incentive program and the state's premier deal closing fund. Virginia must remain competitive to make the short list of site selection projects by increasing funding to the program

Virginia Jobs Investment Program (VJIP). VJIP is the most frequently-used economic development program, as it is accessible to companies of all sizes in every corner of the Commonwealth. The program provides funding and free consulting services to new and existing companies creating new jobs or experiencing technological change. This funding helps offset recruitment and training costs, thus reducing companies' human resource development expenses and reinvesting these funds in the people of Virginia.

Virginia Economic Development Incentive Grant (VEDIG). VEDIG is an important tool to help the Commonwealth achieve its goal to continue to attract significant headquarters, administrative or service sector operations. It should be funded at a level that allows the state to meet current commitments as well as demand by future prospects.



Agriculture and Forestry Industries Development Fund (AFID). AFID is a critical tool for localities to support two of Virginia's largest industries: agriculture and forestry. This performance-based grant is made to companies that create jobs and investment, add value to Virginia-grown products, and commit to sourcing Virginia-grown products – creating additional marketplaces for Virginia's farmers and forestland owners. The AFID program helps both rural and urban localities throughout the Commonwealth attract new and expanding businesses. It is imperative that funding for the program be maintained.

New Economy Workforce Credential Grant. Frederick County supports additional funding to build on the success of the Workforce Credential Grant, a pay-for-performance initiative that creates and sustains a demand-driven supply of credentialed workers to fill occupations where demand outstrips supply in Virginia. The program does this by driving increased attainment, by Virginians, of industry certifications and occupational licenses that count for jobs and business growth. The grant makes attainment of credentials in high-demand fields more affordable to Virginians through the Virginia Community College System.

RE: Targeted Business Update

For over a decade, Frederick County has employed a target industry analysis to analytically identify the County's best fits relative to traded-sector industries – those industries that would most benefit from Frederick County's assets and be willing to expand and/or relocate to the area – and those industries that bring value to Frederick County in the form of investment, jobs, payroll and local purchasing.

This analysis serves several important roles in Frederick County's economic development efforts. Site selectors, corporate real estate leaders and representatives from the Virginia Economic Development Partnership expect communities to provide a list of targeted businesses to show a strategic direction and a proactive nature to business. Additionally, it helps community partners understand where economic development efforts will be targeted.

A brief overview of the methodology is as follows: local industry clusters are identified, along with Frederick County's average wage for those clusters, that information is then compared to the State's high growth sectors and the region's labor availability to arrive at the selected targeted industries. (Full details of methodology used to identify the targeted industries are included.)

Staff is seeking authority approval of the methodology and identification of any specific industry sectors the EDA would like examined.


The following process was utilized to identify target business for Frederick County.

- Step 1 | | Identify average annual wages for employees working in Frederick County
- Step 2 || Cluster Map (LQ) and Large Employers in Frederick County
- Step 3 || Discover what industry sectors in Virginia have high growth and average wages at or above Frederick County
- Step 4 | Review purchasing leakage from Frederick County for current basic employers
- Step 5 || Reviewed detail level data from resulting sectors via Step 3 and 4 who were identified as high growth with wages at or above Frederick County average
- Step 6 || Conducted labor availability test for expansion of average size new business location for Virginia in the past 3 years to ensure talent exists to meet industry demand
