Chairman Gene Fisher called the meeting to order at 5:00 P.M.

(a) Finance Report – J.J. Smith, Secretary/Treasurer – J.J. arrived late; Nick provided an overview of the pre-audit April 2019 financial statements.

- **(d) Marketing Committee Bill Pifer, Chair –** Bill gave an overview of a meeting that he and Nick had with an aircraft management company based in Manassas. It was mentioned that the recent property tax adjustment was a key factor that led to the group exploring options at Winchester.

EXECUTIVE DIRECTOR COMMENTS

Nick mentioned that Frederick County Emergency Management has incorporated drones in to their response capabilities. Frederick County requested a letter from the Authority acknowledging their FAA compliant drone program, including the possibility for operations at the adjacent Public Safety building.

A joint meeting between the Airport Authority and Frederick County Board of Supervisors has been proposed. This seems like a good opportunity to provide a strategic plan update. Planning is in the works with the County Administration office.

Nick discussed upcoming staffing and operational changes. Effective July 1, 2019, all employees will be scheduled a 40 hour workweek. On Saturdays and Sundays the airport will adopt an on-call posture between 2:00AM-6:00AM to make the schedule work with the given manpower resources. This change will protect the overtime budget and ensure personnel funding is available for irregular, extended, or emergency operations.

A kickoff meeting for the first phase of terminal site design will take place in the next 30 days.

There is a based pilot cookout on May 22 from noon to 3PM. Wings & Wheels is on June 1st from 10:00AM-2:00PM.

COMMENTS - BOARD MEMBERS

(a) Joey Bailey – He thought the pilot stakeholder meeting was a success and he looks forward to more initiatives that benefit the general aviation community. He is also encouraged by the fuel sales, and thinks it is the beginning of a positive trend for both Jet-A and AVGAS.
