### Item Requiring Action:

1. Blue Ridge Volleyball Association (BRVA) Agreement Amendment
  - BRVA is proposing funding the installation of a 6<sup>th</sup> sand volleyball court at Clearbrook Park. The agreement recognizes the continued development of the sand volleyball complex and extends BRVA's use of the complex by one year (Attachment 1).

Staff is seeking a recommendation regarding the agreement amendment.

2. Request to allow 2 for 2 to promote 2 for 2 at Blue Ridge United (BRU) games at Sherando Park.
  - The 2 for 2 Foundation is requesting permission to promote the 2 for 2 efforts at Saturday BRU games at Sherando Park in September and October 2022.

**ADDENDA NO. 2**

To the  
MEMORANDUM OF UNDERSTANDING

Between

The COUNTY OF FREDERICK, VIRGINIA (County)

and

the BLUE RIDGE VOLLEYBALL ASSOCIATION (BRVA)

- I. On the 14<sup>th</sup> of December, 2018, the County and BRVA entered into a Memorandum of Understanding (MOU) for the purpose of constructing three (3) sand volleyball courts at Clearbrook Park.
- II. On the 17<sup>th</sup> of November 2020, the County and BRVA entered an addendum NO. 1 Memorandum of Understanding (MOU) for the purpose of constructing two (2) sand volleyball courts at Clearbrook Park.
- III. The parties now mutually desire and agree to amend the reference MOU as follows.
  - Under “BRVA Shall” add “Provide the County a combination of money and materials in the amount of \$20,000 for the construction of one (1) additional sand volleyball court to be located at Clearbrook Park.”
    - Under “The County shall”, remove, “Reserve for BRVA Reserve for BRVA three (3) courts Monday through Friday, five (5) courts two Saturdays per month; five (5) courts two (2) Sundays per month until 1 pm and three (3) courts after 1 pm until December 31, 2029 at no cost to BRVA and replace with “Reserve for BRVA four (4) courts Monday through Friday, six (6) courts two Saturdays per month, six (6) courts two (2) Sundays per month until 3 pm and four (4) courts after 3 pm until December 31, 2030 at no cost to BRVA.”

All other terms and conditions that are not hereby amended are to remain in full force and effect.
