## **GENERAL FOREST MANAGEMENT PLAN – OWNER COMMITMENT**

Your Forest Management Plan can be prepared either by you or by a professional consulting forester. **You should be working toward a commercial timber harvest.**

Your Forest Management Plan needs to include the following:

- Acres in growing managed timber
- Species and size of timber crop present
- Timber management goal(s) (*i.e.*, what purpose **you** are managing and growing timber for)
- How you plan to manage the timber crop
- How soil and water quality issues will be addressed during and after harvest (*i.e.*, adherence to the Best Management Practices in accordance with the Virginia Department of Forestry)
